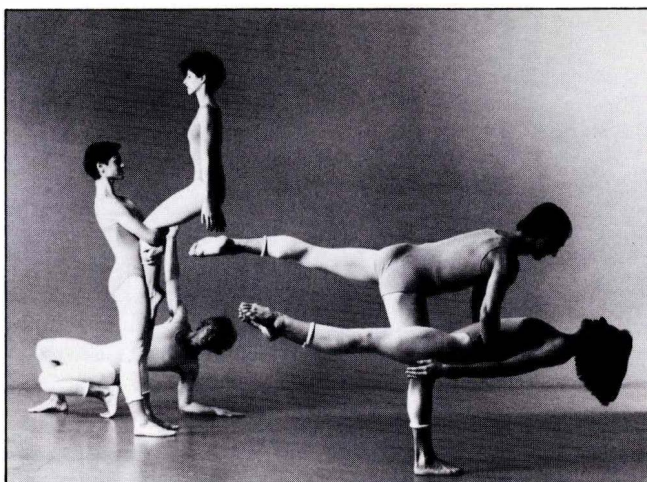

Mark Morris Dance Group

Mark Morris, a native of Seattle, Washington, has performed with a diverse assortment of companies over the years, including the Lar Lubovitch Dance Company, Laura Dean Dancers and Musicians, Eliot Feld Ballet, and Koleda Balkan Dance Ensemble. He founded the Mark Morris Dance Group in 1980.

In addition to his own group, Mr. Morris has created works for the Joffrey Ballet, Boston Ballet, Spokane Ballet, Batsheva Dance Company, and Jacob's Pillow Dancers. He has received several NEA Choreography Fellowships, a 1984 "Bessie" award for choreographic achievement, and a Guggenheim Fellowship.

Since 1984 the Mark Morris Dance Group has toured extensively throughout the United States and Europe, and was featured in an hour-long program on the PBS "Dance in America" series. The company has performed twice at the Brooklyn Academy of Music's Next Wave Festival.

Mr. Morris has recently completed the choreography for "Nixon in China," with music by John Adams and direction by Peter Sellars. The ballet will premiere at the Houston Grand Opera this fall.

New York City Ballet

Founded in 1948 by George Balanchine and Lincoln Kirstein, the New York City Ballet is unique in the artistic history of the United States. It trains its own artists (at the School of American Ballet, formed by Balanchine and Kirstein in 1933); creates its own repertory, composed largely of the works of Balanchine, Jerome Robbins, and Peter Martins; and has two permanent homes: the New York State Theater in New York City and the Saratoga Performing Arts Center in Saratoga Springs, New York.

The company numbers some 100 dancers and counts approximately 90 works in active repertory, of which more than 40 are performed each season. Ranging from "Tchaikovsky Pas de Deux," to the full-length production of "The Nutcracker," from ballets choreographed to the astringent scores of Stravinsky and Hindemith to lush spectacles like "Vienna Waltzes," the New York City Ballet's repertory is one of the most extensive and varied in existence.

In addition to its New York performances, the company has toured throughout the United States and appeared in Australia, England, France, Germany, Denmark, Japan, and the Soviet Union. Balanchine's and Robbins' ballets are in the repertoires of companies all over the world, and dancers trained by the School of American Ballet are members of numerous companies at home and abroad.

Since 1983, Jerome Robbins and Peter Martins have shared the title Ballet Master in Chief, and together they oversee the smooth operation of the New York City Ballet. George Balanchine and Lincoln Kirstein shaped the history of 20th-Century dance, and under the direction of Mr. Martins and Mr. Robbins the company remains dedicated to the preservation of Balanchine's ideals.

**AmFAR
AMERICAN FOUNDATION FOR AIDS RESEARCH**

AmFAR is a national, non-profit organization whose purpose is to support research on AIDS and its complications with funds from the private sector. Additionally, AmFAR provides critically needed public information and education about AIDS.

The AIDS crisis mandates that funding be provided quickly. AmFAR is able to fund projects within three months of application, compared to the government's twelve to eighteen month timetable. In addition, AmFAR's dollars fund approved researched projects that have not yet received adequate support.

GAY MEN'S HEALTH CRISIS**

Gay Men's Health Crisis was the first and, for a long time, the only organization to recognize and confront the emergency of the AIDS epidemic and all of its medical and psychosocial implications. GMHC has taken a leading role in educating health professionals, the general public, and populations at high risk in providing extensive patient support services, and promoting governmental research to find a cure.

GMHC provides an intake and referral program, clinical services, crisis intervention and buddy programs, group services, an ombudsman unit, recreational therapy services, financial and legal services, public information, education, and outreach services.

NATIONAL AIDS NETWORK**

National AIDS Network offers assistance to over 300 member organizations in how to work most effectively within the growing network of AIDS-related resources. It provides a nationwide bank of information and contacts.

National AIDS Network coordinates information regarding health care, education, funding, legal policies, and other guidance to organizations serving local communities.

NAN was created specifically to link AIDS service providers as they seek to develop the most effective programs possible. Its efforts have assisted organizations throughout the country in responding to the multitude of needs spawned by the AIDS epidemic.
